## Order Definitions

Minimum order quantity is 25 linear yards per style with a 10% over/under on any roll size specified.

All prices F.O.B. mill. Put up on three-inch cores.

Same day shipping is not always guaranteed, but if needed, please specify and submit order by 12:00 EST. Additions such as slitting and paper backing will add an extra 1-2 day processing time.

Effective January 1, 2025, a 2.5% surcharge will be applied to payments made via credit card where legally applicable.

Style numbers are typically 4 digits and most are preceded with letters that are associated with product lines: GF (Grand Format), SI (Solvent), DD (Direct Disperse), ET (Enviro-Tex®). Please provide as much of the number as possible. Using only the description such as "Nirvana" is not enough information because we have four different versions of this style.

Latex and UV printers must request trimmed or sealed edges, otherwise rolls have a selvedge edge. Ultra sonic slit/fused edge available at \$0.35/yd surcharge. Sealing edges will lose 3" of width. Trimmed/score cut surcharge is \$0.20/yd and is not a finished edge. Trimming edges will lose 1" of width.

We can slit to any width with an accuracy of +/- 0.25" and can send the end cut if specified.

Solvent, UV, and Direct Disperse styles are stocked with a clean edge.

Heat Setting is available for \$0.50 per linear yard.

Paper Backing is available up to 60" @ \$1.50 per linear yard using 74# paper. Paper Backing of non-Fisher fabric is available @ \$1.75 per linear yard. 100 yard minimum.

We can ship by any shipping carrier and account and have daily UPS, and Estes pickups. Goods wider than 108" must ship via truck line.
